## Trade Associations

From April 1, 2021 through September 30, 2021, Viatris Inc. incurred indirect lobbying costs attributable to trade associations to which Viatris Inc. belongs and which allocate a percentage of membership dues toward lobbying efforts - totaling \$127,500.
